PROVISIONS CONCERNING APPROPRIATIONS

**GENERAL SECTIONS**

19 Sec. 201. In accordance with section 30 of article IX of the  
 20 state constitution of 1963, total state spending from state  
 21 resources in this appropriation act for the fiscal year ending  
 22 September 30, 2017 is \$47,610,900.00. State appropriations paid to  
 23 local units of government are \$37,854,600.00 as follows:

3 subject to the management and budget act, 1984 PA 431, MCL 18.1101  
4 to 18.1594.

5 **MICHIGAN NATURAL RESOURCES TRUST FUND**

6 Sec. 301. (1) The department of natural resources shall enter  
7 into agreements with local units of government to administer the  
8 grants identified in part 1. Among other provisions, the agreements  
9 must require that grant recipients agree to dedicate to public  
10 outdoor recreation uses in perpetuity the land acquired or  
11 developed; to replace lands converted or lost to other than public  
12 outdoor recreation use; and, for parcels acquired that are larger  
13 than 5 acres, to provide this state with a nonparticipating 1/6  
14 minimum royalty interest in any acquired minerals that are retained  
15 by the grant recipient.

16 (2) The agreements under subsection (1) must also provide that  
17 the full payments of grants be made only after proof of  
18 acquisition, or proof of completion of the development project, is  
19 submitted by the grant recipient and all costs are verified by the  
20 department of natural resources. This requirement may be waived by  
21 the department of natural resources.

22 Sec. 302. The appropriations in part 1 for capital outlay  
23 shall be carried forward at the end of the fiscal year consistent  
24 with section 248 of the management and budget act, 1984 PA 431, MCL  
25 18.1248.

26 Sec. 303. (1) The state share of the following capital outlay

1 appropriations authorized in 2014 PA 114 for Michigan natural

 3 grantees is reduced up to the amounts indicated and the money  
 4 lapsed for the purpose of redirecting resources to Michigan natural
