**GENERAL SECTIONS**

9           Sec. 201. In accordance with section 30 of article IX of the  
10 state constitution of 1963, total state spending from state  
11 resources in this appropriation act for the fiscal year ending  
12 September 30, 2017 is \$55,308,200.00 and state spending from state  
13 resources to be paid to local units of government for fiscal year  
14 2016-2017 is \$44,901,900.00. The itemized statement below  
15 identifies appropriations from which spending to local units of  
16 government will occur:

**MICHIGAN NATURAL RESOURCES TRUST FUND**

24           Sec. 301. (1) The department of natural resources shall enter



1 into agreements with local units of government to administer the  
 2 grants identified in part 1. Among other provisions, the agreements  
 3 must require that grant recipients agree to dedicate to public  
 4 outdoor recreation uses in perpetuity the land acquired or  
 5 developed; to replace lands converted or lost to other than public  
 6 outdoor recreation use; and, for parcels acquired that are larger  
 7 than 5 acres, to provide this state with a nonparticipating 1/6  
 8 minimum royalty interest in any acquired minerals that are retained  
 9 by the grant recipient.

10 (2) The agreements under subsection (1) must also provide that  
 11 the full payments of grants be made only after proof of  
 12 acquisition, or proof of completion of the development project, is

 21 appropriations authorized in 2014 PA 114 for Michigan natural  
 22 resources trust fund projects that have since been withdrawn by the  
 23 grantees is reduced up to the amounts indicated and the money  
 24 lapsed for the purpose of redirecting resources to Michigan natural

11 Sec. 304. (1) Pursuant to section 35 of article IX of the  
 12 state constitution of 1963, the legislature hereby makes available  
 13 for expenditure from the Michigan natural resources trust fund  
 14 \$110,650,000.00 of interest and earnings from the fund for  
 15 acquisition and development projects throughout this state.

16 (2) Funds made available for expenditure under subsection (1)  
 17 shall only be spent upon appropriation.
