

# SENATE BILL No. 932

April 11, 2018, Introduced by Senators BOOHER, CASPERSON and HANSEN and referred to the Committee on Natural Resources.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 74101 (MCL 324.74101), as amended by 2010 PA 33.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 74101. As used in this part:

2       (a) "Commercial motor vehicle" means a commercial vehicle as  
3 defined in section 7 of the Michigan vehicle code, 1949 PA 300, MCL  
4 257.7.

5       **(B) "ENDOWMENT FUND" MEANS THE MICHIGAN STATE PARKS ENDOWMENT**  
6 **FUND ESTABLISHED IN SECTION 35A OF ARTICLE IX OF THE STATE**  
7 **CONSTITUTION OF 1963 AND PROVIDED FOR IN SECTION 74119.**

8       (C) ~~(b)~~—"Improvement program" means the construction,  
9 reconstruction, development, improvement, bettering, operating,  
10 maintaining, and extending a facility at a state park, including a

1 site improvement, impoundment, road and parking lot, toilet  
2 building, concession building, shelter building, bathhouse,  
3 utility, outdoor center, visitor service facility, ski area, ski  
4 tow, ski shelter, and administration unit.

5 (D) "LOCAL UNIT OF GOVERNMENT OR PUBLIC AUTHORITY" MEANS A  
6 COUNTY, CITY, TOWNSHIP, VILLAGE, SCHOOL DISTRICT, THE HURON-CLINTON  
7 METROPOLITAN AUTHORITY, OR ANY AUTHORITY COMPOSED OF COUNTIES,  
8 CITIES, TOWNSHIPS, VILLAGES, OR SCHOOL DISTRICTS, OR ANY  
9 COMBINATION THEREOF, WHICH AUTHORITY IS LEGALLY CONSTITUTED TO  
10 PROVIDE PUBLIC RECREATION.

11 (E) ~~(e)~~ "Motor vehicle" means a vehicle that is self-  
12 propelled.

13 (F) ~~(d)~~ "Nonresident motor vehicle" means a motor vehicle  
14 other than a commercial motor vehicle that is not registered as a  
15 motor vehicle in this state.

16 (G) ~~(e)~~ "Recreation passport fee" means that term as defined  
17 in section 2001.

18 (H) ~~(f)~~ "Resident motor vehicle" means a motor vehicle other  
19 than a commercial motor vehicle that is registered as a motor  
20 vehicle in this state.

21 (I) ~~(g)~~ "State park" means a state park or state recreation  
22 area designated by the director.

23 (J) ~~(h)~~ "State park improvement account" means the state park  
24 improvement account of the Michigan conservation and recreation  
25 legacy fund provided for in section 2030.

26 (K) ~~(i)~~ "State park revenues" means all revenues collected for  
27 state parks, including but not limited to, revenue from recreation

1 passport fees, motor vehicle permits, concession fees, nonmotorized  
2 trail permits, fees, leases, camping fees, sale of farm animals  
3 from Maybury state park, donations, and gifts.

4 Enacting section 1. This amendatory act does not take effect  
5 unless all of the following bills of the 99th Legislature are  
6 enacted into law:

7 (a) Senate Bill No. 763.

10 Enacting section 2. This amendatory act does not take effect  
11 unless Senate Joint Resolution O of the 99th Legislature becomes a  
12 part of the state constitution of 1963 as provided in section 1 of  
13 article XII of the state constitution of 1963.
