

HOUSE BILL No. 4261

February 21, 2017, Introduced by Rep. Kosowski and referred to the Committee on Regulatory Reform.

A bill to amend 1996 IL 1, entitled "Michigan gaming control and revenue act," (MCL 432.201 to 432.226) by adding section 9e; and to provide for a referendum.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 **SEC. 9E. (1) THE HOLDER OF A CASINO LICENSE MAY ACCEPT PARLAY**
2 **WAGERS ON SPORTING EVENTS.**

3 **(2) THE BOARD MAY, IN ADDITION TO CASINOS, PROVIDE FOR SPORTS**
4 **BETTING AGENTS TO ACCEPT PARLAY WAGERS ON SPORTING EVENTS TO**
5 **FACILITATE PARLAY SPORTS BETTING IN THIS STATE.**

6 **(3) THE BOARD SHALL DEVELOP A LICENSING AND REGULATORY PROGRAM**
7 **TO LICENSE AND REGULATE SPORTS BETTING AGENTS IN THIS STATE. THE**
8 **BOARD SHALL DEVELOP A SYSTEM THAT ALLOWS PARLAY WAGERS AT RETAIL**
9 **LOCATIONS THROUGHOUT THIS STATE. THE BOARD MAY WORK WITH THE BUREAU**
10 **OF STATE LOTTERY TO MAKE PARLAY WAGERS THROUGH THE STATE LOTTERY**

1 SYSTEM OR A SIMILAR SYSTEM AS DETERMINED BY THE BOARD.

2 (4) THE BOARD SHALL PROMULGATE RULES TO REGULATE SPORTS
3 BETTING AGENTS AND THE CONDUCT OF PARLAY SPORTS BETTING UNDER THIS
4 ACT.

5 (5) AS USED IN THIS SECTION:

6 (A) "PARLAY WAGER" MEANS A SINGLE BET OF 2 OR MORE WAGERS IN
7 WHICH THE WINNERS ARE DETERMINED BASED ON THE OUTCOME OF ANY
8 PROFESSIONAL OR COLLEGIATE SPORTING EVENT, INCLUDING RACING, HELD
9 WITHIN OR WITHOUT THIS STATE.

10 (B) "SPORTS BETTING AGENTS" MEANS INDIVIDUALS LICENSED BY THE
11 BOARD UNDER THIS SECTION TO FACILITATE PARLAY WAGERS IN THIS STATE.

12 Enacting section 1. This amendatory act shall be submitted as
13 provided by the Michigan election law, 1954 PA 116, MCL 168.1 to
14 168.992, to the qualified electors of this state at the next
15 general election held after the effective date of this amendatory
16 act. This amendatory act does not take effect unless it is approved
17 by both of the following at that election:

18 (a) A majority of the electors of this state voting on the
19 question.

20 (b) A majority of the electors voting on the question in the
21 township or city where gambling as authorized under this amendatory
22 act will take place.

23 Enacting section 2. If approved by the electors under enacting
24 section 1, this amendatory act takes effect 10 days after the date
25 of the official declaration of the vote.
