Sec. 201. Pursuant to section 30 of article IX of the state constitution of 1963, total state spending from state sources under part 1 for the fiscal year ending September 30, 2020 is \$6,000,000.00 and total state spending from state sources to be paid to local units of government is \$6,000,000.00.

Sec. 202. The appropriations made and expenditures authorized under this part and the departments, commissions, boards, offices, and programs for which appropriations are made under this part and part 1 are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

Sec. 203. If the state administrative board, acting under section 3 of 1921 PA 2, MCL 17.3, transfers funds from an amount appropriated under this act, the legislature may, by a concurrent resolution adopted by a majority of the members elected to and serving in each house, inter-transfer funds within this act for the particular department, board, commission, office, or institution.

Sec. 301. Funds appropriated in part 1 from the disaster and emergency contingency fund shall be allocated to a county with a population of more than 80,000 and less than 85,000, to a county with a population of more than 200,000 and less than 205,000, to a county with a population of more than 15,000 and less than 16,000, to a county with a population of more than 25,600 and less than

1 25,700, to a county with a population of more than 25,800 and less
2 than 25,900, and to a city with a population of more than 35,000
3 located in a county with a population of more than 80,000 and less
4 than 85,000, according to the most recent federal decennial census.
5 Funding shall be used to support housing assistance costs for
6 individuals displaced from their residence and to reimburse project
7 restoration costs and expenses caused by the disaster impacting
8 those counties. Restoration projects include, but are not limited
9 to, debris removal, emergency protective measures such as road
10 blockades, sheltering, and evacuations, chemical contamination
11 clean-up efforts, and the repair of real estate and personal
12 property. Expenditures for chemical contamination clean-up efforts
13 shall not be made for projects where existing parties are
14 responsible for monitoring and remediating contaminated properties.

15 Sec. 302. The department of state police shall seek
16 reimbursement for flood-related expenditures made from the
17 appropriation in part 1 from the disaster and emergency contingency
18 fund in the event that a court finds that those expenditures have
19 been used to facilitate unlawful conduct.

20 Sec. 303. By September 30, 2020, the department of state
21 police shall submit a report to the senate and house appropriations
22 committees and the senate and house fiscal agencies that includes
23 all of the following information:

24 (a) Name and location of any entity that received funding from
25 the disaster and emergency contingency fund for costs related to
26 the Edenville and Sanford dam incidents.

27 (b) Purpose and use of each expenditure that was made.

28 (c) Amount of federal funding that was provided for flood
29 response related to the Edenville and Sanford dam incidents and an



1 itemization of any expenses covered by the disaster and emergency
2 contingency fund related to these incidents that are eligible for
3 reimbursement.

4 (d) Status of any programs that received support from the
5 disaster and emergency contingency fund due to the Edenville and
6 Sanford dam incidents.

7 (e) Job titles and number of state full-time equated
8 positions, by department, that were engaged in responding to the
9 Edenville and Sanford dam incidents.

10 (f) Listing of all local and county units that applied for
11 disaster and emergency contingency fund assistance grants and the
12 determination that was made on each of the applications.
