A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 224g.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 224g. (1) A person convicted of a misdemeanor crime of
- 2 domestic violence shall not possess, use, transport, sell,
- 3 purchase, carry, ship, receive, or distribute a firearm or
- 4 ammunition in this state.





- 1 (2) A person who is subject to a court order issued under
- 2 section 2950 of the revised judicature act of 1961, 1961 PA 236,
- 3 MCL 600.2950, that contains the prohibition described under section
- 4 2950(30) of the revised judicature act of 1961, 1961 PA 236, MCL
- 5 600.2950, that was issued after a hearing of which the defendant
- 6 had actual notice and at which the defendant had an opportunity to
- 7 participate, shall not possess, use, transport, sell, purchase,
- 8 carry, ship, receive, or distribute a firearm or ammunition in this

- 10 (3) A person who violates this section is guilty of a felony
- 11 punishable by not more than 5 years or a fine of not more than
- 12 \$5,000.00, or both.
- 13 (4) Subsection (1) does not apply to a conviction that has
- 14 been expunged or set aside, or for which the person has been
- 15 pardoned, unless the expunction, order, or pardon expressly
- 16 provides that the person shall not possess a firearm or ammunition.

- 18 (a) "Ammunition" means any projectile that, in its current
- 19 state, may be expelled from a firearm by an explosive.
- 20 (b) "Family or household member" means that term as defined in
- 21 section 1 of 1978 PA 389, MCL 400.1501.
- 22 (c) "Misdemeanor crime of domestic violence" means a
- 23 conviction for any of the following:
- 24 (i) A violation of section 81 if the violation was committed
- 25 against a family or household member.
- 26 (ii) Any other misdemeanor violation of the laws of this state,
- 27 a political subdivision of this state, or of the United States if
- 28 both of the following apply:
- 29 (A) The violation was committed against a family or household
