THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 6. (1) Whenever If the county board of supervisors 1 2 commissioners of any county shall have adopted adopts a resolution 3 to purchase, condemn, or to-accept certain lands for park purposes, 4 and make an appropriation therefor under the provisions of sections 1 and 2, of this act, there shall must be created a board of 3 5 6 members to be known and designated as "county park trustees." the 7 county park trustees. In counties operating under the county road 8 system, the board of county road commissioners is hereby designated 9 and shall then act as the county park trustees.
