

**SUBSTITUTE FOR  
SENATE BILL NO. 753**

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979," by amending sections 201, 205, 206, 207a, 207b, 207c, 216c, 217, 217b, 222, 223, 229, 229a, and 230 (MCL 388.1801, 388.1805, 388.1806, 388.1807a, 388.1807b, 388.1807c, 388.1816c, 388.1817, 388.1817b, 388.1822, 388.1823, 388.1829, 388.1829a, and 388.1830), section 201 as amended by 2023 PA 320, sections 205 and 217 as amended by 2020 PA 165, sections 206, 207a, 207b, 207c, 223, 229a, and 230 as amended by 2023 PA 103, sections 216c and 217b as added by 2023 PA 103, section 222 as amended by 2021 PA 86, section 229 as amended by 2022 PA 144, and by adding sections 216e, 217c, and 217d; and to repeal acts and parts of acts.

4       Sec. 205. To the extent possible, the principal executive  
 5 officer of each community college that receives appropriations in  
 6 section 201 shall take all reasonable steps to ensure ~~businesses in~~

 8 **disadvantaged business enterprises** compete for and perform  
 9 contracts to provide services or supplies, or both. Each principal  
 10 executive officer shall strongly encourage businesses with which

28 through industry partnerships, incubation activities, or operation

2 (v) The community college has active partnerships with local  
3 or regional workforce and economic development agencies.

4 (b) For Category B, educational partnerships, the following:

5 (i) The community college has active partnerships with regional  
6 high schools, intermediate school districts, and career-tech  
7 centers to provide instruction through dual enrollment, concurrent  
8 enrollment, direct credit, middle college, or academy programs.

9 (ii) The community college hosts, sponsors, or participates in  
10 enrichment programs for area K-12 students, such as college days,  
11 summer or after-school programming, or Science Olympiad.

12 (iii) The community college provides, supports, or participates  
13 in programming to promote successful transitions to college for  
14 traditional age students, including grant programs such as talent  
15 search, upward bound, or other activities to promote college  
16 readiness in area high schools and community centers.

17 (iv) The community college provides, supports, or participates  
18 in programming to promote successful transitions to college for new  
19 or reentering adult students, such as adult basic education, a high  
20 school equivalency test preparation program and testing, or  
21 recruiting, advising, or orientation activities specific to adults.  
22 As used in this subparagraph, "high school equivalency test  
23 preparation program" means that term as defined in section 4.

24 (v) The community college has active partnerships with  
25 regional 4-year colleges and universities to promote successful  
26 transfer, such as articulation, 2+2, or reverse transfer agreements  
27 or operation of a university center.

28 (c) For Category C, community services, the following:

29 (i) The community college provides continuing education

1 programming for leisure, wellness, personal enrichment, or  
2 professional development.

3 (ii) The community college operates or sponsors opportunities  
4 for community members to engage in activities that promote leisure,  
5 wellness, cultural or personal enrichment such as community sports  
6 teams, theater or musical ensembles, or artist guilds.

7 (iii) The community college operates public facilities to  
8 promote cultural, educational, or personal enrichment for community  
9 members, such as libraries, computer labs, performing arts centers,  
10 museums, art galleries, or television or radio stations.

11 (iv) The community college operates public facilities to  
12 promote leisure or wellness activities for community members,  
13 including gymnasiums, athletic fields, tennis courts, fitness  
14 centers, hiking or biking trails, or natural areas.

15 (v) The community college promotes, sponsors, or hosts  
16 community service activities for students, staff, or community  
17 members.

18 (4) Payments for performance funding under section 201(2) must  
19 be made to a community college only if that community college  
20 actively participates in the Michigan Transfer Network sponsored by  
21 the Michigan Association of Collegiate Registrars and Admissions  
22 Officers and submits timely updates, including updated course  
23 equivalencies at least every 6 months, to the Michigan Transfer  
24 Network. The state budget director shall determine if a community

29 IX of the state constitution of 1963, total state spending from

4 estimated at \$470,341,700.00 and the amount of that state spending  
5 from state sources to be paid to local units of government for  
6 fiscal year 2024-2025 is estimated at \$469,491,700.00.

7 Enacting section 2. Section 216d of the state school aid act

10 Enacting section 3. This amendatory act takes effect October  
11 1, 2024.
