HOUSE BILL NO. 4665

May 25, 2023, Introduced by Reps. Snyder, O'Neal, Liberati, McFall, McKinney, Price, Tyrone Carter and Paiz and referred to the Committee on Labor.

A bill to amend 1986 PA 182, entitled "State police retirement act of 1986,"

by amending sections 3 and 4 (MCL 38.1603 and 38.1604), as amended by 2018 PA 674.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. (1) "Banked leave time program" means the part B
- 2 annual leave hours within the state's annual and sick leave program
- 3 approved by a ruling of the Internal Revenue Service on September
- 4 5, 2003, in which a pay reduction or other concessions are applied
- 5 to a member in exchange for additional part B annual leave hours.

- (2) "Credited service" means the sum of the prior service and
 membership service credited to a member's account.
- 3 (3) "Deferred member" means a member who separates from
 4 service with entitlement to a deferred retirement allowance as
 5 provided in section 30, but who is not a retirant.
- 6 (4) "Department" means the department of technology,7 management, and budget.
- 8 (5) "Direct rollover" means a payment by the retirement system9 to the eliqible retirement plan specified by the distributee.
- 10 (6) "Distributee" includes a member or deferred member.11 Distributee also includes the member's or deferred member's
- 12 surviving spouse or the member's or deferred member's spouse or
- former spouse under an eligible domestic relations order, with
 regard to the interest of the spouse or former spouse.
- 15 (7) "DROP participant" means an officer who participates in 16 the deferred retirement option plan established in section 24a.
- 17 (8) Beginning January 1, 2002, except as otherwise provided in 18 this subsection, "eligible retirement plan" means 1 or more of the 19 following:
- 20 (a) An individual retirement account described in section 21 408(a) of the internal revenue code, 26 USC 408.
- 22 (b) An individual retirement annuity described in section 23 408(b) of the internal revenue code, 26 USC 408.
- 24 (c) An annuity plan described in section 403(a) of the 25 internal revenue code, 26 USC 403.
- 26 (d) A qualified trust described in section 401(a) of the 27 internal revenue code, 26 USC 401.
- 28 (e) An annuity contract described in section 403(b) of the 29 internal revenue code, 26 USC 403.

- 1 (f) An eligible plan under section 457(b) of the internal 2 revenue code, 26 USC 457, that is maintained by a state, political 3 subdivision of a state, or an agency or instrumentality of a state 4 or political subdivision of a state and that agrees to separately 5 account for amounts transferred into the eligible plan under 6 section 457(b) of the internal revenue code, 26 USC 457, from this 7 retirement system, that accepts the distributee's eligible rollover
- 9 (g) Beginning January 1, 2008, a Roth individual retirement 10 account as described in section 408A of the internal revenue code, 11 26 USC 408A, subject to the rules that apply to rollovers from a 12 traditional individual retirement account to a Roth individual

- (a) A distribution made for the life or life expectancy of the
 distributee or the joint lives or joint life expectancies of the
 distributee and the distributee's designated beneficiary.
- 21 (b) A distribution for a specified period of 10 years or more.
- 22 (c) A distribution to the extent that the distribution is
 23 required under section 401(a)(9) of the internal revenue code, 26
 24 USC 401.
- (d) The portion of any distribution that is not includable in
 federal gross income, except to the extent the portion of the
 distribution is paid to either of the following:

1 (ii) A qualified plan described in section 401(a) of the

5 including any portion of the distribution that is includable in
6 federal gross income, and the portion of the distribution that is

(10) "Final average compensation" means, except as otherwise provided in this subsection, the average annual salary for the last 2 years of service with the department of state police, department of corrections, department of health and human services, department of natural resources, or department of environment, Great Lakes, and energy, as applicable, for which the member was compensated as defined in subsection (13). Except as otherwise provided in this subsection, for a nonclassified member of the department holding the rank of colonel, final average compensation means the same average annual salary as that computed for the highest salaried classified member of the department, or at the average annual salary for the last 2 years of service with the department of state police for which the member was compensated, whichever is greater. Beginning with the effective date of the amendatory act that added section 42a, December 28, 2018, for a member who first became a member on or after June 10, 2012, final average compensation means the average salary for the last 5 years of service for which the member was compensated as defined in subsection (14). Average annual salary includes only the following compensation items:

(a) Beginning with the effective date of the amendatory act that added section 42a, December 28, 2018, for a member who first became a member before June 10, 2012, only the following

- 1 compensation items:
- 2 (i) Regular salary paid for the last 2 years of service,
- 3 including, but not limited to, that salary that is deferred
- 4 pursuant to a state deferred compensation program.
- (ii) Overtime, shift differential, and shift differential
- 6 overtime paid for the last 2 years of service.
- 7 (iii) Gross pay adjustments paid affecting the last 2 years of
- 8 service, including compensatory time and emergency response
- 9 compensation.
- 10 (iv) Up to a maximum of 240 hours of accumulated annual leave,
- 11 paid at the time of retirement separation excluding part B annual
- 12 leave hours paid at the time of retirement separation.
- (v) Deferred hours under Plan B of the fiscal years ending
- 14 September 30, 1981, and September 30, 1982, that are paid at the
- 15 time of retirement separation.
- 16 (vi) Longevity pay equal to 2 full years.
- 17 (vii) Bomb squad pay paid for the last 2 years of service.
- 18 (viii) Post 29 freeway premium paid for the last 2 years of
- 19 service.
- 20 (ix) On-call pay paid for the last 2 years of service.
- 21 (x) Beginning October 1, 2003, the value of any unpaid
- 22 furlough hours or the value of any unpaid hours exchanged for part
- 23 B annual leave hours, calculated at the member's then-current
- 24 hourly rate or rates of pay, for a period during which a member is
- 25 participating in the banked leave time program.
- 26 (xi) Beginning May 1, 2009, the value of temporary layoff
- 27 hours. As used in this subparagraph, "temporary layoff hours" means
- 28 hours attributable to the layoff of a member if the layoff does not
- 29 exceed 1 month and has a fixed, predetermined, and announced recall

- 2 (b) Beginning with the effective date of the amendatory act
- 3 that added section 42a, December 28, 2018, for a member who first
- 4 became a member on or after June 10, 2012, only the following
- 5 compensation items:
- 6 (i) Regular salary paid for the last 5 years of service,
- 7 including, but not limited to, that salary that is deferred
- 8 pursuant to a state deferred compensation program.
- 9 (ii) Shift differential.
- 10 (iii) Gross pay adjustments paid affecting the last 5 years of
- 11 service, including compensatory time and emergency response
- 12 compensation.
- 13 (iv) Up to a maximum of 240 hours of accumulated annual leave,
- 14 paid at the time of retirement separation excluding part B annual
- 15 leave hours paid at the time of retirement separation.

- 17 (vi) Bomb squad pay paid for the last 5 years of service.
- 18 (vii) Post 29 freeway premium paid for the last 5 years of

- 20 (viii) On-call pay paid for the last 5 years of service.
- 21 (ix) The value of any unpaid furlough hours or the value of any
- 22 unpaid hours exchanged for part B annual leave hours, calculated at
- 23 the member's then-current hourly rate or rates of pay, for a period
- 24 during which a member is participating in the banked leave time
- 25 program.
- 26 (x) The value of temporary layoff hours. As used in this
- 27 subparagraph, "temporary layoff hours" means hours attributable to
- 28 the layoff of a member if the layoff does not exceed 1 month and
- 29 has a fixed, predetermined, and announced recall date.

- (11) "Furlough hours" means unworked hours incurred in
 conjunction with the banked leave time program.
- 3 (12) "Internal revenue code" means the United States internal4 revenue code of 1986.
- 5 (13) "Last 2 years of service" means the 2-year period 6 immediately preceding the member's last day of service or that 7 period of 2 consecutive years of service with the department of 8 state police, department of corrections, department of health and 9 human services, department of natural resources, or department of 10 environment, Great Lakes, and energy, as applicable, immediately 11 preceding the date the duty disability occurred according to the medical examinations conducted under section 29 or, if the officer 12 participated in the deferred retirement option plan, the 2-year 13 14 period immediately preceding participation in the deferred
 - (14) "Last 5 years of service" means the 5-year period immediately preceding the member's last day of service or that period of 5 consecutive years of service with the department of state police, department of corrections, department of health and human services, department of natural resources, or department of environment, Great Lakes, and energy, as applicable, immediately preceding the date the duty disability occurred according to the medical examinations conducted under section 29.
- Sec. 4. (1) "Member", except where the context otherwise requires, means an any of the following:

- 6 properties securities officer who is first employed and entered on
- 7 the payroll after September 30, 2024. An individual described in
- 8 this subdivision is treated as an individual who first becomes a
- 9 member after June 9, 2012.
- 10 (2) "Officer" means a nonexclusively represented member of the
- 11 retirement system.
- 12 (3) "Qualified participant" means an individual who first
- 13 becomes a member on or after June 10, 9, 2012 and who is also a
- 14 participant of Tier 2.
- 15 (4) "Regular interest" means a rate or rates per annum,
- 16 compounded annually, as the retirement board determines. For the
- 17 purposes of employee refunds, the interest rate payable must not
- 18 exceed 4% per annum, compounded annually.
- 19 (5) "Retirant" means a member who separates from service and
- 20 retires with a retirement allowance payable from the appropriate
- 21 reserve of the retirement system.
- 22 (6) "Retirement allowance" means the annual amount, payable
- 23 monthly, to which a retirant, retirement allowance beneficiary, or
- 24 refund beneficiary is entitled under this act.
- 25 (7) "Retirement allowance beneficiary" means a person who is
- 26 being paid or has entitlement to the payment of a retirement
- 27 allowance in the event of the death of a member, deferred member,
- 28 or retirant.
- 29 (8) "Retirement board" means the retirement board created in

- 1 section 6.
- 2 (9) "Retirement system" means the system of benefits for
- 3 members and qualified participants of the department of state
- 4 police and their survivors and beneficiaries provided by this act.
- 5 (10) "Surviving spouse" means the spouse at the time of death of the member or retirant.
- 7 (11) "Tier 1" means the retirement plan available to a member 8 under this act.
- 9 (12) "Tier 2" means the retirement plan established pursuant 10 to section 401(k) of the internal revenue code, 26 USC 401, that is 11 available to qualified participants under sections 62 to 74.
