HOUSE BILL NO. 4666

May 25, 2023, Introduced by Reps. O'Neal, Snyder, Liberati, McFall, McKinney, Price, Tyrone Carter and Paiz and referred to the Committee on Labor.

A bill to amend 1943 PA 240, entitled "State employees' retirement act,"

by amending section 55 (MCL 38.55), as amended by 2011 PA 264, and by adding sections 50b, 50c, 50d, 64a, 64b, and 64c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 50b. (1) Subject to subsection (4), the retirement system
- 2 shall provide an opportunity for each eligible position qualified
- 3 participant on October 1, 2024 to elect in writing to terminate

- 16 qualified participant on October 1, 2024 to elect in writing to
- 17 terminate being a qualified participant and elect to become a
- 18 member of the Michigan state police retirement system created under
- 19 the state police retirement act of 1986, 1986 PA 182, MCL 38.1601
- 20 to 38.1674. An election made by a conservation officer qualified
- 21 participant under this subsection is irrevocable. The retirement
- 22 system shall accept written elections under this subsection from
- 23 conservation officer qualified participants beginning on January 1,
- 24 2024 and ending at 5 p.m. Eastern Daylight Saving Time, June 1,

- Sec. 50d. (1) Subject to subsection (4), the retirement system
- 28 shall provide an opportunity for each state police qualified
- 29 participant on October 1, 2024 to elect in writing to terminate

- 1 being a qualified participant and elect to become a member of the
- 2 Michigan state police retirement system created under the state
- 3 police retirement act of 1986, 1986 PA 182, MCL 38.1601 to 38.1674.
- 4 An election made by a state police qualified participant under this

- 26 (e) Was a member who made the election under section 50a(1)

 27 years of credited service or who has terminated employment and has
 28 been reemployed by this state.
- 29 (f) Was a member as described in section 50a(6), (7), or (8).

- 1 (3) "Qualified participant" does not include any of the

- 4 term is defined in section 50b, to whom both of the following
- 5 apply:
- 6 (i) Elects to terminate being a qualified participant under

- 8 (ii) Is first employed and entered on the payroll before

- 10 (b) An individual employed in an eligible position, as that
- 11 term is defined in section 50b, who is first employed and entered
- 12 on the payroll after September 30, 2024.
- 13 (c) A conservation officer as that term is defined in section
- 14 lb, other than a conservation officer described in section 48, to
- 15 whom all of the following apply:
- 16 (i) Elects to terminate being a qualified participant under
- 17 section 50c.
- 18 (ii) Is first employed and entered on the payroll before
- 19 October 1, 2021.
- 20 (d) A conservation officer as that term is defined in section
- 21 45, other than a conservation officer described in section 48, who
- 22 is first employed and entered on the payroll on or after October 1,

- 24 (e) A state police motor carrier or Michigan state police
- 25 properties securities officer to whom all of the following apply:
- 26 (i) Elects to terminate being a qualified participant under
- 27 section 50d.
- 28 (ii) Is first employed and entered on the payroll before
- 29 October 1, 2024.

(f) A state police motor carrier or Michigan state police properties securities officer who is first employed and entered on the payroll after September 30, 2024.

 6 section 66 to receive a distribution of the participant's
 7 accumulated balance in the manner prescribed in section 67.
 - (5) $\frac{(4)}{(4)}$ "State treasurer" means the treasurer of this state.
- (6) (5) "Tax-deferred account" means an account or accounts of existing deferred compensation plans or plans established by the retirement system, for which the retirement system has the authority to determine the membership, eligibility, terms, conditions, and other administrative and operational features. Tax-deferred account does not include a health reimbursement account for purposes other than complying with the contribution limits described in section 68b(12).
 - of service" means each period during which a qualified participant is employed by the employer and is credited with 2,080 hours of service. The Tier 2 plan administrator and the plan document may provide for a lesser number of annual hours and a maximum number of hours per pay period for any classification of employees, provided that no but a participant shall may not receive credit for more than 1 year of service for any 12-month period of employment.

- 13 Tier 2 to purchase service credit under the state police retirement
- 14 act of 1986, 1986 PA 182, MCL 38.1601 to 38.1674, as provided in
- 15 section 24c of the state police retirement act of 1986, 1986 PA
- 16 182, MCL 38.1624c. As used in this section, "eligible position
- 17 qualified participant" means that term as defined in section 50b.
- 18 Sec. 64b. A conservation officer who elects to terminate being
- 19 a qualified participant under section 50c may transfer part or all
- 20 of his or her contributions made to Tier 2 and, subject to the
- 21 vesting schedule under section 64, transfer part or all of employer
- 22 contributions made on his or her behalf to Tier 2 to purchase
- 23 service credit under the state police retirement act of 1986, 1986
- 24 PA 182, MCL 38.1601 to 38.1674, as provided in section 24d of the
- 25 state police retirement act of 1986, 1986 PA 182, MCL 38.1624d.
- 26 Sec. 64c. A state police motor carrier or Michigan state
- 27 police properties securities officer who elects to terminate being
- 28 a qualified participant under section 50d may transfer part or all
- 29 of his or her contributions made to Tier 2 and, subject to the

- 1 vesting schedule under section 64, transfer part or all of employer
- 2 contributions made on his or her behalf to Tier 2 to purchase
- 3 service credit under the state police retirement act of 1986, 1986
- 4 PA 182, MCL 38.1601 to 38.1674, as provided in section 24e of the
- 5 state police retirement act of 1986, 1986 PA 182, MCL 38.1624e.
