- 1 A resolution to declare May 2023 as Foster Care Awareness
- 2 Month in the state of Michigan.
- 3 Whereas, Recognizing National Foster Care Awareness Month is
- 4 an opportunity to shine a light on the challenges children in the

- 1 foster care system face and encouraging the Legislature to
- 2 implement policy to improve the lives of children in the foster

- 3 care system; and
- 4 Whereas, It is also a time to acknowledge foster parents,
- 5 family members, volunteers, mentors, policymakers, and child
- 6 welfare professionals who help children and youth in foster care
- 7 find permanent homes and connections. We use this time to renew our
- 8 commitment to ensuring a bright future for the more than 407,000
- 9 children and youth in foster care and we celebrate those who make a
- 10 meaningful difference in their lives; and
- 11 Whereas, Children in foster care who are placed with
- 12 relatives, compared to children placed with nonrelatives, have more
- 13 stability, including fewer changes in placements, have more
- 14 positive perceptions of their placements, are more likely to be
- 15 placed with their siblings, and demonstrate fewer behavioral
- 16 problems; and
- 17 Whereas, An increased emphasis on prevention and reunification
- 18 services is necessary to reduce the number of children that are
- 19 forced to remain in the foster care system; and
- 20 Whereas, More than 23,000 youth "age out" of foster care every
- 21 year without a legal permanent connection to an adult or family,
- 22 according to the National Foster Youth Institute; and
- 23 Whereas, Children who age out of foster care lack the security
- 24 and support of a biological or adoptive family and frequently
- 25 struggle to secure affordable housing, obtain health insurance,
- 26 pursue higher education, and acquire adequate employment; and
- Whereas, Children entering foster care often confront the
- 28 widespread misperception that children in foster care are
- 29 disruptive, unruly, and dangerous, even though placement in foster

- 1 care is based on the actions of a parent or guardian, not the
- 2 child; and
- 3 Whereas, According to the Michigan Department of Health and
- 4 Human Services, children in foster care may be at greater risk for
- 5 mental health problems; now, therefore, be it
- 6 Resolved by the House of Representatives, That the members of
- 7 this legislative body declare May 2023 as Foster Care Awareness
- 8 Month in the state of Michigan. We encourage more citizens to
- 9 volunteer their time to become mentors to children in foster care
- 10 and we realize that the state of Michigan must do more to support
- 11 these children and prepare them to live healthy and productive
- 12 lives.
